

Apply For UK Visitor Visa Application & Requirements in (2025)



If you're looking to apply and come to the UK on a visit visa to see the UK, visit family members, attend a wedding or a graduation ceremony or other reasons, then the standard visit visa is the right visa to apply for.

Not everyone will require prior entry clearance with a visa to come to the UK. If you are from a visa national country you will be exempt from applying from outside the United Kingdom for entry clearance. However, border officials will still need to be satisfied with your reason for visiting the UK, that you have enough money to fund your trip and will return back to your home country. If you are from a non-visa national country you will require prior entry clearance (a visa) and your main reason for entering the UK.

Visitor visas in the UK allow you to travel for short term stays of up to six months and can be used for visiting family, your partner, for UK holidays, for medical reasons, attending a short course business or English language course among other reasons. Tourism and Leisure Visit Visa holders cannot engage in unpaid work, receive payment from a UK source for any activities undertaken in the UK.

You must have sufficient funds to cover all reasonable costs in relation to your visit without working or accessing public funds. This includes the cost of your return or onward journey, any costs relating to dependants, and the cost of planned activities. There are additional requirements or documents

that may be required when you apply for an online UK visitor visa. Your application will be considered by an Entry Clearance Officer (ECO).

What are the visa types of UK Standard Visitor Visa And Who Is It For?



Leisure:

Whether coming for a family visit, sightseeing, or general travel, your needs fall under the standard visa.

Business:

If you need to enter the UK for short term business requirements such as conferences, events or business appointments, then the general visitor visa UK will allow you to travel to the UK to do your business here for a period of up to six months.

Other Reason:

The standard visitor route can also allow you to travel to the UK if you are receiving private medical treatment, for instance.

What are the Requirements and What Documents Do I Need to Apply for a UK Visitor Visa?

To prove your eligibility for the UK visitor visa, it's important to provide the Home Office with evidence of the general requirements for eligibility as part of your UK visit visa requirements and application. You'll need to demonstrate that:

- You are a genuine visitor
- You have a valid current passport or travel document
- You have full intention to leave the UK at the end of your visit or whole of your stay and do not plan to stay for longer than six months.
- You have evidence of any activities you intend to perform while in the UK, including business and other activities.
- You can afford your inward and outward journey including flights.
- You have access to sufficient funds in order to support yourself and any dependents throughout your stay without accessing public funds in the UK
- You have adequate travel insurance and have made suitable arrangements
- The application form is online

The exact documents will vary case by case and it is important you get the relevant and correct documents as part of your application. Tourism and Leisure Visit Visa holders are not permitted to work or receive any remuneration for any activities in the UK. As you can see, the Immigration rules are strict and the Home Office refuses a lot of visas on the basis of a lack of supporting original documents or the right evidence not being submitted. It is therefore important you disclose and provide an accurate picture of your personal circumstances as part of the application process. As part of your application, you and your family dependants will need to provide biometric fingerprints and submit their original passport and documents in your home country local visa application centre.

How Much Does A Visitor Visa UK Cost?

The following application fees apply depending on a 6 months to a 10 year multi visitor visa.

- 6 months visitor visa £115
- 2-Year Visa – £400
- 5-Year Visa – £771
- 10-Year Visa – £963

It is important to check the home office website www.gov.uk as the fees are regularly changing.

How long does the visa decision process take?

The average visa processing time is 2-3 weeks, sometimes longer for applicants outside the EEA and Switzerland. You can take steps to track the application processing period and view your UK visa processing status as it changes. If you're travelling to the UK for an urgent reason you can choose to pay for the Priority Fast Track services.

Is there a right of appeal against a UK refusal decision?

- Apply for judicial review subject to merits or
- Apply for a fresh new visa application.

The reality is that rejections for UK general standard visitor visas are very common and getting a refusal decision does not mean you cannot re-apply again for a fresh or new application or challenge the decision by way of judicial review proceedings, which is quite costly and expensive. Therefore, it is essential there are sufficient merits for a proposed application for JR. If you wish to re-apply and submit a fresh application, we will ensure the previous refusal points are completely addressed and you have all the correct documents to strengthen your application for the visa to be granted.

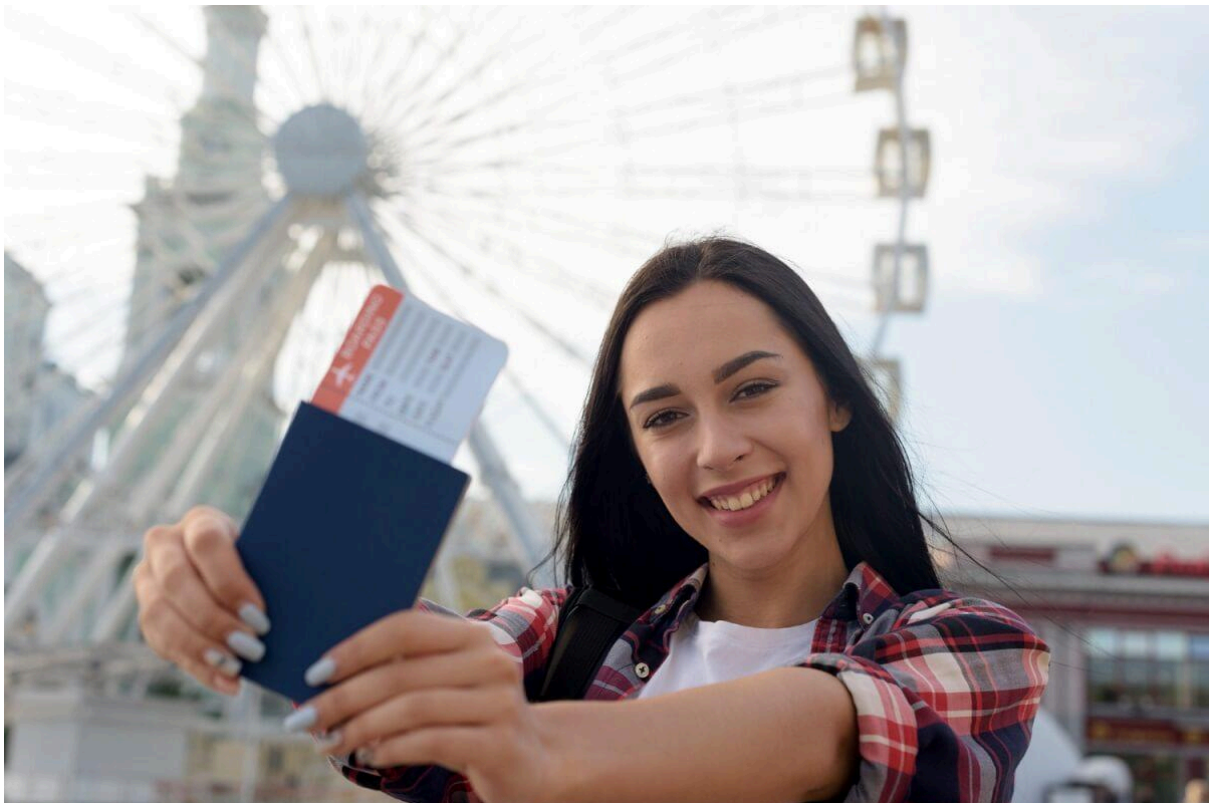

The Standard Visitor Visa Category Covers A Range Of Other Visas:



The visitor visa allows foreign nationals subject to UK immigration laws to enter the country for a short period for a range of different reasons such as a family wedding, a graduation ceremony, an important business conference, a private medical appointment, or something else that you can't afford to miss. This is because the standard UK visit visa covers a range of other types of visas for UK travel and various sub-categories of visas, including:

Family Visit Visa:

For non-EEA nationals wanting to travel to the UK for a family visit, it's necessary to apply for the UK family visitor visa category. As standard, this visa allows you to stay in the UK for up to six months to see family. When visiting the UK under the family visit visa, you aren't permitted to work or claim public funds while here. You can also bring dependents with you, meaning that if you're planning on

travelling with other family members, you'll need to make sure that each travelling family member has a valid family visit visa UK.

It's also the case that UK family visit visas are difficult to obtain compared to other types of UK visa.

Child Visitor Visa:

Any non-EEA national under the age of 18 needs to apply for a child visitor visa before travelling to the UK. This is another visa that falls under the standard visitor visa category and is required for any under-18 with UK travel plans. Whether travelling to visit family or friends, as part of an exchange programme, or for education, the child visitor visa covers you for up to six months of UK travel. [Visa applications for child](#) visas need to be thorough.

Business Visitor Visa:

This visa will allow you to attend conferences and training, complete academic work, participate in some sporting events, negotiate and sign deals and contracts, and carry out inspections, among other functions. However, you can't do any paid work or access public funds while in the UK. You're eligible for the business visitor visa regardless of whether you are working for an employer or self-employed.

Student Visitor Visa:

If you're a visiting UK visa national hoping to study on a short term basis for a short course of study subject to meet the eligibility requirements. Also known as the short-term study visa, this is a type of UK visa that allows you to travel to the UK to study for no longer than six months.
